Vision of the LEG in supporting adaptation in the LDCs



The provision of support by the LEG and other actors for achieving demonstrable results in building adaptive capacity, strengthening resilience and reducing vulnerability to climate change in the LDCs; formulation of robust and good-quality NAPs and implementation of priority adaptation needs identified therein with funding from the GCF and other sources; and existence of a well-structured adaptation planning process in the LDCs



Expected outcomes for long-term success

- Policymakers in the LDCs motivated to implement actions;
- All the LDCs having in place national structures and systems (the essential functions) for NAPs;
- All the LDCs having submitted a NAP by the end of 2023 or soon thereafter;
- All the LDCs implementing priorities identified in their NAPs using GCF and other funding;
- Coherent and complementary activities in formulating and implementing NAPs;
- Adaptation strategies and actions being well integrated with national development efforts.



Expected adaptation outcomes and actions

Adaptation project pipelines; implementation of adaptation actions; formulation of NAPs; strengthening national processes; etc.

Increased volume of adaptation projects funded through the FM and other sources; implementation of adaptation actions; iterative NAPs; effective processes; etc.


By 2030, all LDCs are resilient to climate change and have adaptive societies, economies and ecosystems



- Assist the LDCs in identifying obstacles and addressing this obstacles through targeted support i.e. data challenges or capacity gaps






Accelerating the NAP process through open source & open-ended software



NAP Data Initiative

- Access to usable data, in particular climate scenario data, usually ranked high in gaps related to addressing adaptation and formulating NAPs
- In addition to climate data/scenario data, there are numerous global and regional datasets that have been meticulously put together for various (global) studies
- Managing huge datasets is cumbersome, costly, and can be daunting when conducting assessments and preparing the NAP








NAP implementation pipeline development

- The NAP Implementation Pipeline Development initiative assists countries in identifying project ideas that can be used to develop concept notes or proposals for submission to the Green Climate Fund (GCF), as well as the Least Developed Countries Fund (LDCF) and the Adaptation Fund (AF)
- The LEG facilitates the development of project ideas through the NAP writing workshops, country dialogues, Open NAPs, and the work of the NAP implementation subgroup





Key outputs

- The 2022 NAP writing workshops totaled more than 50 project ideas:
 - **2** concept notes had been **submitted to the** GCF (Central African Republic, Togo);
 - ❖ 3 project ideas had been developed into full concept notes (Ethiopia, Sudan);
 - **34** project ideas are at **advance** stages of development.
- The 2023 NAP Writing Workshop for African LDCs and Haiti, in Comoros totaled 31 project ideas and revised the project ideas initially developed in 2022.
