# Two objectives of the process to formulate and implement National Adaptation Plans



To reduce vulnerability to the impacts of climate change by building adaptive capacity and resilience;



To facilitate the integration of climate change adaptation, in a coherent manner, into relevant new and existing policies, programmes and activities, in particular development planning processes and strategies, within all relevant sectors and at different levels, as appropriate.

### The NAP and the underlying process



#### <u>Process</u>

The **process** of supporting the work on adaptation, vertically integrated from observations and research, analysis, assessments, priority setting, plans and their implementation, then reporting, monitoring and review. These are ongoing and long-term activities, and include activities to enable them (stocktaking, identifying gaps and obstacles, addressing those gaps, etc.).



#### Plan

The NAP, the plan, which is a statement of what is known and prioritized for a given time slice - to inform implementation, monitoring and evaluation, and many other uses as explained below. The NAP formulated and communicated should thus give details about the process, and also include information about how the process will be continued and supported, to lead to more and better plans the next time slice – in an iterative manner;

#### **Highlights from previous NAP Expos**

#### **Observations**

- Countries are making noteworthy progress on their NAPs. They are building on their national circumstance and ongoing milieu of adaptation activities;
- There is growing evidence of effective adaptation solutions, and more work is needed to identify a broader set of good practices and successes
- Learning is an important part of adaptation, and the opportunity exists to systematically learn from deliberate experimentation and trials, as well as from dealing with climate shocks;
- Vast amounts of data exist, some of which can inform assessments and planning, and several large-scale models can offer valuable results
- There is a vibrant support system for the NAPs by many agencies and programmes.
   Opportunities exist to focus and coordinate technical support to achieve better and more consistent results;
- Use of a systems approach is useful in providing greater specificity as countries shift from formulation to implementation;





#### **Regional NAP Expo Objectives**

- a. To facilitate the interaction between country NAP teams and providers of support, including the GCF, GEF and AF, as well as bilateral agencies and other relevant organizations, to enhance access to financing for NAPs;
- To discuss country experiences, best practices, lessons learned, gaps and needs and information on support provided and received in relation to the process to formulate and implement NAPs;
- c. To offer a platform for countries to interact with the GCF and others providing support for NAPs, as a means to improve access to financing for NAPs.

Incubation of new ideas to facilitate the transformation of adaptation planning and implementation;

Communities of practice – on specific themes such as food security; regional approaches, vulnerable groups, communities and ecosystems; gender; role of youth; local level adaptation etc.

Regional cooperation – such as on transboundary adaptation projects; early warning systems, sharing of data; pooling of technical resources and knowledge; and exchange of experience, good practices and lessons learned at regional level;

Joint publications and products – publications; technical guidelines; good practices and lessons learned in implementing adaptation; case studies on assessing adaptation needs, demonstrating the adaptation need; etc.
