## Overview of the NAP Writing Support

#### **NAP Writing Support**

At its 41<sup>st</sup> meeting, the LEG noted that the number of project proposals submitted by the LDCs for accessing funding from the GCF for implementing priority adaptation projects associated with their NAPs remains low;

□ The LEG also noted the **lack of effective support** for the LDCs for developing project proposals;

□ To address such issues, the LEG is supporting the LDCs to move towards successful adaptation through the NAP Writing Support.

The NAP writing support assists countries in identifying project ideas that can be used to develop concept notes or proposals for submission to the Green Climate Fund (GCF), as well as the Least Developed Countries Fund (LDCF) and the Adaptation Fund (AF)



# The implementation of adaptation priorities is accelerated through:

Identification of project idea themes/areas by countries based on their NAP priorities, where available, or other existing plans and strategies, in alignment with the GCF country programme

Identification of delivery partner(s), agency(ies) or designated authority(ies) to support the development of project ideas into project proposals; Initial development of the identified project ideas with the support of the LEG and all mobilized partners through the NAP country dialogues and NAP writing workshops;

Development of the project ideas into project concept notes/proposals with the support of delivery partner(s), agency(ies) or designated authority(ies) the countries decided to work with, and their submission to the GCF, the GEF, the AF and other sources of funding.

#### Framing



- NAP project proposal writing support – generating project profiles
- LEG, NAP teams, GCF NDAs, GEF OFPs, AF, DAs, etc.
- Concept note development with AEs, NIEs/DAEs
- Review and approval by funding entities such as AF, GCF and GEF
- Disbursement and implementation
- Monitoring and evaluation



#### Workshop objectives & expected outcomes

The workshop objective is to provide a space for the country teams to initiate and/or further develop their project ideas into concept notes / proposals for submission for funding to the AF, GCF and LDCF.

Support to all countries to **effectively develop their project ideas** into concept notes or project proposals for submission to the AF, GCF and LDCF

Hands-on technical assistance to **submit the first NAP** as soon as possible, as well as **updating/revising the first NAP** where applicable Support to all countries to develop roadmaps for 2023 and the medium-term, and to identify technical support from the LEG and other providers of support to best assist them to implement their NAP
